TCWD requires that all water meters be free of obstruction to allow for reading of meters and emergency repairs. The meter reader must have safe access to the meter at all times, including the initial landscaping of which the property owner is liable for damages to the meter and/or meter box by the landscaping contractor. The meter has an electrical component for electronic reading and may not be tampered with or moved without inspection and written permission by TCWD.

In consideration of the connection, I hereby agree to pay all flat charges and fees for water and/or sewer and for water consumption through said connection at the rates fixed by the resolution of the TCWD Board of Directors, and the same shall be a lien on the land until paid in full. No sale, lease or modification to customer of record (for utility billing purposes) of the described property will release or relieve me from such charges.

I agree not to supply, furnish, or permit to be obtained, water through the connection to any land or buildings not shown on the plot plan.

It is agreed that the meter and all pipes and connections leading to the same are and shall remain the sole property of TCWD, and TCWD will have unrestricted right of ingress and egress for inspections, maintenance, repair and replacement.

I further agree to abide by all Rules and Regulations of the District including, but not limited to the Water Conservation Ordinance 2008-19, which went into effect on January 1, 2009.

This contract shall at all times be subject to change or modification by the TCWD as said District may, from time to time, direct in the exercise of its jurisdiction.
