Special Board Meeting-Budget Workshop

Mr. Ruiz said that District staff is currently working with the District Treasurer on this matter, and that the workshop will be scheduled for late May due to the implementation of new rates and charges from Metropolitan Water District of Southern California (MET) and MWDOC. Mr. Ruiz added that MET and MWDOC are currently undergoing rate studies which will impact the District's Fiscal Year 2016/2017 General Fund Budget. Discussion occurred concerning the planned workshop budget presentation.

Discussion occurred concerning the current status of the recycled water conversion project for T-Y Nursery. Mr. Ruiz reported that the District's contractor has completed the District's portion of the project up to and including the meter, and that T-Y Nursery has received project approval from MET. Mr. Ruiz added that the size of the onsite HDPE pipeline was increased from a two-inch pipeline to six-inch, and that this project will assist the District in meeting the State Water Board's mandatory drought regulations and it's conservation standard of 28%.

RECOMMENDED ACTION

ITEM 3: LEGISLATIVE INFORMATIONAL ITEMS

ITEM 4: REPORTS OR COMMENTS FROM THE GENERAL MANAGER AND/OR STAFF

Mr. Ruiz reported the following matters:

Mr. Ruiz presented a press release from the South Orange County Wastewater Authority (SOCWA)
concerning the closure of the AWMA Bridge due to its substandard condition and current state of disrepair,

and mentioned that the press release will be included at the Regular Board Meeting for Board review.

- Mr. Ruiz reported that the District has posted a Wastewater Treatment Operator in Training open position in the Wastewater Operations Department. Discussion occurred concerning the District's organizational transition plan and staffing needs and challenges.
- Mr. Ruiz reported that the District is scheduled to receive approximately \$5.1 million from the Bank of New York Mellon as a result of the defeasement of the Series A Bond. Discussion occurred concerning investment strategies; Mr. Ruiz said that the District Treasurer will adhere to the District's Reserves Policy regarding the investment of the funds, and that any new investments will be reviewed with the Finance/Audit Committee prior to investment.
- Mr. Ruiz reported that District staff plans to contract with an independent, third-party consultant for a Total Compensation and Salary Survey before the end of the budget cycle. Discussion occurred concerning organizational staffing levels and assumptions; Mr. Ruiz said that the matter will be presented at a future Regular Board Meeting before the end of the fiscal year.
- Mr. Ruiz reported that County of Orange has requested the financial reports for both the Trabuco Canyon Improvement Corporation (TCIC) and Trabuco Canyon Public Financing Authority (TCPFA) for year ended June 30, 2015. Mr. Ruiz added that since the financial reports are normally approved at the annual meeting, that District staff recommends the scheduling of Special Meetings of the TCIC and TCPFA in the month of April to comply with this request. Discussion occurred concerning the annual meeting date of the TCIC and TCPFA, and the possibility of changing the annual meeting date; Mr. Ruiz said that annual meeting date is adopted by resolution per the bylaws of the TCIC and agreement of the TCPFA, and as such, would be presented for adoption at the July 2016 Annual Meetings.

RECOMMENDED ACTION

The Executive Committee recommended that District staff schedule a Special Meeting of the Trabuco Canyon Improvement Corporation and Trabuco Canyon Public Financing Authority in the month of April.
