# ITEM 1: APPROVAL OF CONTRACT FOR THE DISTRICT'S 2021 SYSTEMWIDE MASTER PLAN AND CONDITION ASSESSMENT

In 1999, Trabuco Canyon Water District (District) approved the Water, Wastewater and Recycled Water Master Plan (Master Plan) developed by Montgomery Watson. Since that time, the District has evolved into a fully developed, and nearly a "built out" community. Several of the Capital Improvement Projects (CIP) and recommended actions identified in the 1999 Master Plan have been implemented. The District recognizes the need to update the 1999 Master Plan and develop the tools needed to assist in planning, operating, and maintaining District aging water, nondomestic water systems and sewer infrastructure. As the District's infrastructure ages, it is crucial to identify the needed system improvements with particular attention to the condition and operation of existing reservoirs, pump stations, lift stations, and treatment faciliies and allowing sufficient time to plan, finance, and construct the improvements.

In September 2021, District Staff received three proposals for engineering services which included a master plan update and condition assessment of the District's facilities. The firms who proposed on the Project are summarized below:
