## **SECURING YOUR** WATER FUTURE

Trabuco Canyon Water District is proud to provide reliable water, wastewater and recycled water services 24/7-365 to maintain our community's health and safety.

TCWD is currently considering a rate increase to cover the rising costs of providing these critical services and to reinvest ratepayer funds into infrastructure rehabilitation projects and technological upgrades.

As a public water and wastewater utility, TCWD's ratesetting process is regulated by state law. We cannot charge our customers more than the cost associated with the services we provide.

#### **KEEPING PACE WITH RISING COSTS**

Since the pandemic, TCWD has faced the same unprecedented cost increases that our customers have felt at home and at work, including more expensive electricity, fuel and the highest inflation in 40 years. Construction costs have increased due to labor shortages and delays in acquiring parts and equipment. Plus, TCWD services require a lot of electricity to pump water up to the high elevations we serve.

TCWD's costs to operate, maintain and replace the water, wastewater and recycled water utilities continue to increase. These costs include:

- 1. The costs to purchase, treat, store and deliver water, which includes energy costs to move water throughout the system.
- 2. Wastewater collection, treatment and biosolid disposal costs.
- 3. Recycled water treatment, storage and distribution costs.
- 4. Critical reinvestment in aging capital facilities for all three utilities.

While TCWD has been able to use its financial strength and reserves to help buffer our customers from these impacts, it can not do so indefinitely.

The proposed rate increases to support the cost of operations are due to the following cost drivers:



JUNE

The cost to purchase and treat water



Water and wastewater treatment chemicals

Significant increases in electricity and gas prices

Compliance with state and federal regulations and mandates



Construction of infrastructure improvements needed for aging water and sewer systems



District labor necessary to maintain the operations of the district



Ongoing maintenance of vital infrastructure

### **CAPITAL INFRASTRUTURE INVESTMENT**

TCWD invests ratepayer funds into projects that are critical to ensuring the quality and reliability of water and sewer service to over 13,000 customers. The District plans to spend \$47 million over the next 10 years for the ongoing rehabilitation of our treatment plants, pump stations, reservoirs, transmission mains, as well as valve replacements and future water reliability projects.



#### THE VALUE OF TAP WATER



At your tap, TCWD water costs <u>only one penny</u> <u>per gallon</u> to deliver safe, clean drinking water to every home and business from sources up to 400 miles away!



Over two-thirds of TCWD's expenses do not vary with the amount of water sold; they support the services and infrastructure that are ready to serve customers 24 hours a day, including adequate flow and pressure to protect life and property due to fires or other disasters.
