The Trabuco Canyon Public Financing Authority (the "Authority") is a joint exercise of powers authority formed for the purpose of, among other matters, undertaking financings and refinancings for the benefit of the Trabuco Canyon Water District. The Joint Powers Exercise of Powers Agreement which formed the Authority allows the Authority to adopt regular meeting dates by resolution. RESOLUTION NO. 2024-21

RESOLUTION OF THE BOARD OF DIRECTORS OF THE TRABUCO CANYON PUBLIC FINANCING AUTHORITY ESTABLISHING REGULAR MEETING DATES

WHEREAS, the Trabuco Canyon Public Financing Authority (the "Authority") is a joint exercise of powers authority duly organized and operating pursuant to Chapter 5, Division 7, Title 1 of the California Government Code (commencing with Section 6500) (the "JPA Act") and is authorized by the terms of the Joint Exercise of Powers Agreement, dated as of August 18, 1993 (the "JPA Agreement"), by and between the Trabuco Canyon Water District (the "District") and Community Facilities District No. 7 of the Trabuco Canyon Water District, to among other matters, undertake the financing and refinancing of the acquisition, installation and construction facilities within the boundaries of such parties; and

WHEREAS, to fulfill its purposes, the Authority, from time to time, authorizes the issuance of bonds pursuant to the JPA Act including Article 4 (commencing with Section 6584) of Chapter 5, Division 7, Title 1 of the California Government Code therein; and

WHEREAS, Government Code Section 6592.1 provides that the Authority may adopt a resolution authorizing bonds or any issuance of bonds or accepting the benefit of any bonds or the proceeds of bonds only during a regular meeting of the Authority held pursuant to Government Code Section 54954; and

WHEREAS, Section 3.2(a) of the JPA Agreement provides that the Authority may by resolution fix the dates upon which, and the hour and place at which, any regular meeting of the Authority shall be held; and

WHEREAS, the Authority desires to adopt this resolution in accordance with the provisions of Section 3.2(a) of the JPA Agreement and Government Code Sections 6592.1 and 54954 to establish dates for regular meetings of the Authority.

THEREFORE, THE BOARD OF DIRECTORS OF THE TRABUCO CANYON PUBLIC FINANCING AUTHORITY HEREBY RESOLVES, DETERMINES AND ORDERS AS FOLLOWS:

Section 1. Each of the foregoing recitals is true and correct.

Section 2. In accordance with Section 3.2(a) of the JPA Agreement and notwithstanding any prior resolutions or actions of the Authority to the contrary, regular meetings of the Authority shall be held at the same time and place as regular meetings of the board of directors of the District, which regular meetings may be held as a joint meeting of the Board of Directors of the Authority and the board of directors of the District and may be adjourned or continued from time to time as permitted by law, including as set forth in Government Code Sections 54955 and 54955.1. In the event that the Secretary determines that there is no business of the Authority to be conducted at the

regular meetings set forth in this Section 2, then each of the President, Vice President, the Secretary and other officers of the Authority are authorized to take whatever actions are required by law to cancel such regularly scheduled meetings.

<u>Section 3</u>. The President, Vice President, Secretary and Treasurer of the Authority are authorized and directed, jointly and severally, to do any and all things which they may deem necessary or advisable in order to effectuate the purposes of this resolution, and such actions previously taken by such officers are hereby ratified and confirmed.

Section 4. This resolution shall take effect immediately upon its adoption.
